#### XI. REPORTS

- A. <u>Engineer's Status Report</u> Council Member, Wallace W. Ross, Jr. asked Cody McElroy if there was going to be funding available for the sidewalk project. Cody McElroy stated that there was left over funding from last year that he was working on making available, and that he was trying to obtain Highway Safety Funds. Council Member, Wallace W. Ross, Jr. asked about the emergency shower project. Cody McElroy explained to him that it was necessary due to the chemicals that the employees are working with at the water plant. However, he stated that the quote he received looked a little high and he was waiting to speak with Town Manager, Greg Jones, before proceeding with acquiring more quotes.

- **C.** <u>Codification Committee/Property Maintenance</u>- Town Attorney, Michele Brooks stated that we were moving forward with publication. Mayor, Frances Perry stated that the town was moving forward with demolishing the condemned buildings in town and making Gate City look better.

- **D.** Police Department Report- Sergeant, Justin Miller stated that he had been looking through old records and he has discovered that in previous years there were approximately 437 citations issued by the end of the fiscal year. This year our department is at 627 citations. Also in previous years there has been approximately 66 arrests; this year we are at 76 arrests. He believes that this is because they finally have a Chief that leads from the front. He also attributes the credit towards Officer Dustin Folk for his efforts and ability to get drunk or intoxicated drivers off the road.
- **E.** Council Reports- Council Member, Robin Richards stated that she had received a couple of emails regarding Kicking Back @ King Alley. The first stated that they are really enjoying the event and believe it to be great for the town, but they would like to see a food truck available. The second stated that they are glad the town is having this event as they usually sit at home on Friday nights, but now have somewhere to go. Council Member, Wallace W. Ross, Jr. stated that he had questions. Mayor, Frances Perry stated that if he had questions he should have asked them prior to the meetings. Council Member, Wallace W. Ross, Jr. stated that he thought that was what these meetings were for. Mayor, Frances Perry stated that he could go ahead and ask his questions and they could try and answer those questions. Council Member, Wallace W. Ross, Jr. stated that he saw an article in the VML magazine that Big Stone Gap was mentioned for having a movie filmed there. He feels that we should try to get Gate City mentioned because it has already been used as a film location.
