- VIII. <u>UNFINISHED BUSINESS</u> Board Member, D. Breeding, questioned the status of the smoke test. Town Manager, G. Jones, informed the Board it will start in the Spring when it warms up. Chairman/Council Member, R. Cassell, discussed the Engineer RFP status of ranking the eight applicants, narrowing it to three, and interviewing the. He informed the Board of the three interviewed as Mattern & Craig, Lane Group and Thompson & Litton. He stated once approval is received from VDOT, regarding their selection, it will be presented to Council for their approval.
- IX. <u>NEW BUSINESS</u> Town Manager, G. Jones, explained about three bonds with long term debt that are listed as Rural Development and paying 5% on them. He asked for approval from the Sanitation Authority to see if he can better percentage rates for some cost savings. He stated the market is around 3-3 ³/₄ right now. He stated VRA will help some with lower percentage than that. Chairman/Council Member, R. Cassell, asked about the length of the current loans. Town Manager, G. Jones, responded 40 years. He explained the process of the loans that VRA would look has to be newer than July 1, 1993. If they are old than that date we would have to go out to the private market place to refinance and may not get a better rate.
