



## **GATE CITY PLANNING COMMISSION**

September 1, 2015

The regular monthly meeting of the Gate City Planning Commission was held Tuesday, September 1, 2015 at Gate City Town Hall at 6:00 pm.

### **CALL TO ORDER:**

Chairman Delany Herron, called the meeting to order at 6:01 pm and asked the secretary to call the roll.

### **DETERMINATION OF A QUORUM:**

### **PUBLIC EXPRESSION:**

Ms. Cynthia Ericsson appeared before the Commission to provide further information concerning her request that a portion of the un-opened "Old Rye Cove Road" adjoining her property be closed. Ms. Ericsson provided a map obtained from the Scott County Commissioner of Revenue that shows the location of two adjoining properties owned by James Williamson and one belonging to Albert Hammonds. Ms. Ericson states that Mr. Hammond's property can be accessed from Manville Road. Mr. Williamson has a driveway to his home directly off Chestnut Street. His second lot does not appear to have public road access. Mr. Greg Jones had printed a map from the Gate City real estate tax base that show the properties in a different location in relation to Ms. Ericson's property. Mr. Jones will meet with a representative of the Scott County Commissioner of Revenue's office to clarify the differences in the two maps. Copies attached.

The Commission's concern remains that closing the un-opened road might deny access to surrounding, potentially developable properties.
