#### VIII. <u>UNFINISHED BUSINESS</u>

Sanitary Sewer System policy "Draft 3-12-14" – Town Attorney, M. Brooks, stated updates were sent today to Town Manager, but E-mail service was down and he did not receive the changes. Changes were addressing the Class 1 Misdemeanors to be Class 3 Misdemeanors, with fines being up to \$100.00 per day versus an offense of jail time as being the only thing to change. This is the maximum punishment for everything, in the last Section 53 to change to a Class 3 Misdemeanor versus a Class 1 and under Section 33 would be up to \$200 and the cost of repair plus 20% that is restitution for damages. That's restitution, not a fine. The board discussed availability fees, mandatory hook-up for new construction and Jim Craft's recommendation for language to address the dumping of a septic tank trucks and campers into the sewer system.

#### IX. <u>NEW BUSINESS</u>

 Discuss PSA's Daniel Boone Extension – Chairman/Council Member, R. Cassell, discussed the signs up on Daniel Boone Road regarding community meetings for interest in the sewer and has talked to some about this. He stated the last time Dan Danko attended our meeting it was discussed. in the near future, they would be looking at putting new lines in the Daniel Boone area and would have to either lay another line or use our existing line. He spoke to Melinda from PSA today and was informed one of their Engineers was filling in for Dan Danko who will be retiring on July 1, 2014. He spoke to the Engineer prior to this meeting and was informed they are no further along than they were last year, had one meeting and only received 10 user agreements, they have about 70 in the whole area and they are spend out, with a couple individuals who are really pushing for it. The Engineer hoped to receive enough agreements to do it, but at present no funding has been applied for they are looking at interest. Board discussed installation of line across the railroad tracks and most are below grade that would require a pump. R. Cassell invited them to attend our meeting with their meeting being held the second Tuesday of every month at 9 a.m. at the Board of Supervisors room. Roger Cassell informed the Board the Lane Group is the Engineer for PSA the same gentleman who was here at the meeting with Dan Danko and Andy Miles when they discussed the condition of the trunk line. The Engineer informed R. Cassell no decision has been reached as to what they will be doing. R. Cassell informed the Engineer the main trunk line condition was not as bad as they were told. The Engineer informed R. Cassell of four flow meters they can put into our lines at various locations which are radio read for a fee, if the Town is interested to use.
