Town Manager, S. Templeton – If you have anyone in mind.

Chairman, J. Craft – He suggests sending a letter to Mr. McMillan asking him if he wants to continue on the board. If not, to let us know or give us a letter of resignation, so we can declare that slot open, and advertise for it.

Town Attorney, M. Jenkins – Agrees, saying that would be appropriate.

Town Manager, S. Templeton – States we will take care of that tomorrow.

Council Member, R. Cassell - It would be nice if we could fill both of them, but one more would be nice.

Town Manager, S. Templeton – He repeats. If any of you know of someone who might be interested encourage them to complete an application
