Jim McElroy advised it was his understanding that he would be hearing from DEQ soon for a final inspection at the plant. DEQ has been contacted with no date given for final inspection. Mr. McElroy advised the plant has 198,000 gallons of sludge at the plant.

**DISMANTLING OF OLD STATION**

Mike Carrico questioned the plans for closing procedures.

Andy Miles stated that he is familiar with another locality that has gone thru the same situation, he suggest we get with DEQ and ask for plans that will be able to tell the Sanitation Authority the proper steps laid out in the document that has already been approved showing the proper steps to close out the plant.

Mike Carrico made the suggestion to the Board that Andy Miles who acts as the Town of Gate City's Engineer also be appointed to represent the Sanitation Authority to speak with DEQ.

Turning over the property from the Sanitation Authority to the Town of Gate City will be discussed once dismantling is completed.
