# **C.) GATE CITY TOWN ATTORNEY:**

Mrs. Brooks clarified questions relating to property at 1553 E. Jackson Street that contains a commercial business structure in an R-1 residential zone. That property was never re-zoned. It remains in the R-1 residential zone.

#### **UNFINISHED BUSINESS:**

Continued discussion of the up-dating of the Gate City Zoning Ordinance. Mr. Cassell stated that he has a list of street names before the E-911 re-addressing that changed or added street names which are not reflected in the existing Ordinance.

#### **NEW BUSINESS:**

Planning Commission heard a request from Mr. Delany Herron to remove a single-wide mobile home on property he owns at 1241 W. Jackson St., Gate City. Ms. Debra Likens rents space on Mr. Herron's property for a single-wide mobile home which she wishes to replace with a new, larger single-wide mobile home. The area is zoned R-2 which does not permit single wide-mobile homes. The Commission requested information concerning the available space for the new home, relative to set-back and side yard requirements. Mr. Herron will provide that information.

A motion for continuation until Wednesday February 3, 2016 at 6:30 pm. was made by Margaret Falin and seconded by Vickie Roberts. The purpose of this adjourned meeting will be to discuss Mr. Herron's request for a permit to place a single-wide mobile home on his property at 1241 W. Jackson Street.
