He also included information concerning potential future access to their property which has been cut off by V-DOT guardrails alongside U.S. 23 S.
- 2) Mr. Jones has prepared a draft amendment to the C-1 and C-2 zoning ordinance to include residential housing. These changes will be presented at a public hearing conducted by the Gate City Town Council.
- 3) Picnic tables for Gateway Park and the proposed dog park should be arriving within the next week.

The Commission, after examining the current occupations permitted in residential neighborhoods, agreed that on-line, in home businesses should be included in section 24-1-42 of the zoning ordinance.
