The regular monthly meeting of the Gate City Planning Commission was held Tuesday, August 1, 2017 at Gate City Town Hall at 6:00 pm.

CALL TO ORDER:

UNFINISHED BUSINESS:

- 1) (a) Brief discussion of the location of the picnic tables at Gateway Park. Members are in agreement that the tables should be separated to provide more privacy to users.
 - (b) Discussion of need for trash receptacles at the park.
 - (c) Discussion of need to get signage at park as soon as possible.
- 2) (a) Greg Jones reported that only two qualifying estimates have been received for tree removal at the proposed Dog Park.

- (b) Mr. Jones stated that he has one estimate for electrical service at Gateway Park but that he would like to have more estimates before the job is awarded.
- 3) Review of proposed amendments to the Sections 30-182, C-1 and 30-214, C-2 of the Comprehensive Zoning Ordinance along with updates to Section 30-3, Definitions.

Motion made by Jo Ann Castle and seconded by Vickie Roberts to recommend to Town Council that proposed changes to the zoning ordinance be adopted by Council.

4) Mr. Jones has sent letters to 13 landowners soliciting input on the possibility of locating a horse riding and BMX course on their property lying South of US 23 extending from the Gateway Plaza Shopping Center toward the western city limits. He has not yet received replies from any landowners.

ITEMS NOT ON AGENDA:

- 1) Jo Ann Castle reported seeing several visitors stumble and one child fall, scraping his knees, in the gap between the sidewalk and the abutment that holds the pedestrian walk sign at the corner of Jackson Street and King Alley. Mr. Jones responded that those abutments are set away from the sidewalk edge to facilitate the passage of rainwater toward the storm drains. Ms. Castle asked if a pipe could be placed there and set into concrete so there is no gap between the sidewalk and the abutments.
- 2) Vicky Roberts questioned whether the 'Welcome to Gate City' sign could be relocated to a more visible site. At its present site, it is not visible to visitors entering Gate City from US Hwy 23-N.
