#### III. <u>NEW BUSINESS</u>

#### • Waste Water Line Replacement Project

-Roger Cassell read letter from Jason Snapp that summarizes the progress of the project thus far. This letter summarized reads,

"The town will need to get surface water permit approval from the VA Marine Resources Commission. Fish and mussel surveys are required as part of their review. The 2018 audit must be completed before commitment letter can be issued for this project before summer 2019. Two options are available for continuation of the project. Option one: Proceed with the fish and mussel surveys; pass findings onto USACE and VDGIF for review; USACE would pass these along to find out what fish and wildlife would require to release the permit; this is approximately a 180 day process; rough cost estimate is \$5,000; relocation of species is also \$5,000; these costs can be classified as refundable through the DEQ package. Option two: Remove creek crossing from project entirely; no species survey requirement; approximately 60-day project."

-Place line under creek (it is now above ground) 8" lateral line in concrete encasement

-DEQ, Bill Spencer recommends putting line under ground

-Greg Jones going ahead and getting the line replaced even though it may take a little extra time, it will help with problems that could occur in the future

-Bob voting AYE if proposal goes to vote (for underground and complete project)
