#### **NEW BUSINESS:**

- 1) Ankit Patel, Rakesh Patel, Mike Patel and William Pritchard requested a Special Exception and Use permit for the operation of a Skills Gaming Room in Gate City. Mr. Pritchard, acting as spokesperson, answered Commission members' questions concerning the object of and operation of the game room.
  - Attorney Michelle Brookes explained that she had requested an opinion from the Scott County Commonwealth's Attorney on the legality of opening such a business in Gate City. Mr. Johnson's reply will determine whether the application process can proceed.

2) Mr. Billy McClellan requested a Special Exception and Use permit to install a mobile home on property located in the R-2 residential district at 145 Woodland Street. Mr. McClellan stated the property belongs to his daughter and is currently under court order for property maintenance clean-up.

It was explained to Mr. McClellan that his daughter must first meet the terms of the court order and then he can submit his request for a permit.
