X. NEW BUSINESS

- **Mattern & Craig: DEQ/WasteWater Line Replacement Project Update**

Mr. Jason Snapp delivered the DEQ/Waste Water Line Replacement Project update. Mr. Snapp stated that most of the Little Moccasin Creek Line that was added back into the project has been replaced. Mr. Snapp stated that 180 ft of the line and one manhole has not been installed due to a time of year restriction within 100 ft of the bridge due to bats. Mr. Snapp stated that the restriction will be lifted on October 31st. Chairman Roger Cassell asked what is the time frame of the restriction? Mr. Snapp stated that the restriction typically starts on April 15th and end on October 31st. Mr. Snapp stated that he has looked for other manholes around town to replace but did not see any that would be beneficial to replace. Mr. Snapp stated that four to nine manholes will need to be restocked. Chairman Roger Cassell asked if Mr. Snapp has looked at the manhole on Nickelsville Highway? Mr. Snapp stated that he and Town Manager Greg Jones will need to look at that again but that it may be more economical for the town to put in a riser cone.

Mr. Snapp stated that he feels that the pipe restocking fee has went down due to using some of the pipe, but the manholes cost may go up since there were originally only four to be restocked. Mr. Snapp stated that the line that was going to have two manholes installed on it cannot be found and is most likely in the creek. Mr. Snapp stated that to find the line, a new permit would have to be filed and it would drastically extend the project. Mr. Snapp did not recommend trying to find the line. Mr. Snapp stated that the majority of the line has been installed and stabilized and has helped the sewage flow behind Patriot Fuels. Chairman Roger Cassell asked if the line is in the creek, what keeps the water from getting into it? Mr. Snapp stated that the line is ductile iron and has been videoed. Mr. Snapp stated that he feels comfortable that there is negligible infiltration in that section of pipe. Mr. Snapp stated that pipe bursting it would be a waste of money due to the small amount of infiltration and the size of the line. Mr. Snapp stated that a permit would cost more to file than it would to restock the manholes. Mr. Snapp stated that the Town should see a \$500,000 savings over what the original budget was. Chairman Roger Cassell asked if there may be somewhere to use the manholes in the SSES grant? Mr. Snapp stated that it may be possible and they will look for places to use them. Chairman Roger Cassell stated that the flow coming into the plant is far less than before.

Mr. Snapp stated that he has given the Sewer Asset Management Plan to Town Manager Greg Jones and a .pdf will be sent to the Sanitation Authority.

- **PSA Contract Issue**

Town Attorney Michele Brooks stated that she received a document on Friday from PSA Attorney Freddie Mullins that she has sent to Town Manager Greg Jones. Town Attorney Michele Brooks stated that she will also send it to the rest of the committee. Town Attorney Michele Brooks stated that we are waiting on additional files from Mattern & Craig. Town Manager Greg Jones stated that he will also be receiving information from DEQ tomorrow. Town Attorney Michele Brooks stated that as soon as the additional information is obtained, we will push for a meeting with PSA.
