Proposal Guidelines:

Section 1: Introduction

The Town of Gate City (hereinafter referred to as the "TOWN") invites qualified design firms or professionals (hereinafter referred to as "CONTRACTOR") for website redevelopment. Proposals must be submitted by the specified due date.

Redesigns should incorporate consistent branding and messaging across all sites, restructure the sites' hierarchy for improved user experience, direct to portals for citizens' bill transactions, and encourage visitors to explore the TOWN's businesses.

At launch, all sites will need to be optimized for search engine indexing and configured for analytics tracking. As it is imperative that the TOWN personnel be equipped to make content management updates, training sessions should be factored into proposals.

The CONTRACTOR should be able to perform technical website updates, as needed, and provide ongoing performance reporting on key user metrics.

It is imperative that the CONTRACTOR have previous website development experience with a municipality or county agency, preferably within Southwest Virginia. Familiarity with the TOWN is preferred. The CONTRACTOR must be registered with the Commonwealth of Virginia State Corporation Commission.

Section 2: Proposal Submission

Submit sealed proposals to Greg Jones, Town Manager. Proposals must be received by the deadline and be clearly marked "Webpage Redevelopment Project."

Section 3: Contractor Qualifications

Contractors must meet various standards including adequate financial resources, relevant skills, and a satisfactory performance record.
